

Personalisation of care and support

A transition programme for housing providers and commissioners

The drive to place people at the centre of the services they receive, involving them in service design and delivery, is a major priority for the Coalition Government for all public services. The Personalisation programme in care and support is accelerating; by April 2013, personal budgets will be the norm in Adult Social Care. At the same time, Fair Access to Care Services criteria are increasing to serve only critical cases and in many localities there will be less money available to meet individuals' lower-level support needs.

Despite the 'bad news' of significant budget cuts, providers and commissioners of housing, care and support can respond positively to these changes. You can develop community-based approaches to supporting people's health and well-being, alongside specific personalised support delivered to individuals. You can capitalise on the changes in public health, demonstrating the cost-effectiveness of your 'preventative and early intervention' services. You can attract new self-paying customers by offering greater choice and control. The precise route that you take will depend on many factors, but if you don't act to transform your service or commissioning style you risk being left behind. Kate McAllister and Merron Simpson have joined forces, and in association with the Housing Learning and Improvement Network (LIN), have designed a programme for both providers and commissioners as they explore and implement ways of making the transition.

The Programme

1. Diagnostic, options appraisal and assistance in moving forward
