The NHS nationally already spends 70% of its budget on the 15m people who have one or more of these conditions. With an ageing population, patient numbers nationally are expected to grow by 23% over the next 20 years. This session will:

BY ROAD:

York Racecourse is just outside the city of York with good motorway links on the M1 and A1. Once near the city, from the south, east and west the A64 and A1036 are the roads to follow. From the north, use the A19 and A59, then the York Ring Road to avoid the city centre.

CAR PARKING:

There is ample free car parking at York Races. Please follow directional signs at all times.

BY RAIL/PUBLIC TRANSPORT:

Fast and frequent rail services take as little as 1 hour 52 minutes from London Kings Cross and some 2.5 hours from Edinburgh. Manchester and Birmingham are also direct. (The course is 1 mile from the station and City Centre) For station information, train times and routes please visit National Rail's website <u>http://www.nationalrail.co.uk</u>

If arriving into York Train Station, the best way to reach the Racecourse is either via taxi costing approximately £5.00 or via bus costing approximately £2.50 for a return fare.

'First' operate a bus service to the Racecourse, details are as follows:

- Service 4 operates every 10 minutes and drops off at Tadcaster Road (approx 5 minutes walk to the Racecourse entrance)
- Service 12 & 13 operates every 30 minutes and drops off at Tadcaster Road (approx 5 minutes walk to the Racecourse entrance)
- Service 11 operates every 30 minutes and drops off at Knavesmire Road (approx 2 minutes walk to the Racecourse entrance)
