Surrey County Council's Priority Objectives



Guiding Mission: **'No one left behind'**.



Context

- Affordability and supply of accommodation in Surrey impacts the quality of life, health outcomes and wellbeing of Surrey residents.
- It acts as a constraint in attracting and retaining a strong workforce, particularly within sectors to support an aging population.
- Recognising the importance of the agenda, Inner Circle Consulting were appointed to develop the Surrey Accommodation, Houses and Homes Strategy bringing partners together to drive change within what is a complex multi-dimensional, multi-partner landscape.



Surrey Housing, Accommodation and Homes Strategy in Summary

Conclusions:

- A housing crisis exists in Surrey!
- Affordability is the critical issue median house prices higher than national and South-East averages

Surrey has become *more unaffordable, more quickly*, rising 50% since 2011, compared to 40% across SE

 Recommendations were made for local and national action



Challenges Identified

High Demand and limited supply

- Surrey has an aging population with a lack of suitable accommodation to meet their meets and to support independent living.
- The limited supply of suitable and affordable accommodation places a strain on core local public services, contributes to issues of homelessness, challenges in finding placements for looked after children and suitable accommodation for care levers.
- Land available for residential development is constrained by the green belt
- Housing stock is old and requires investment to improve efficiency and suitability.

Recommendations



Surrey County Council delivery

"Right Homes, Right Support" programme

Ambition to delivery over 1,400 units of specialist accommodation across Surrey.

Supporting the shift from institutionalised residential care to specialist accommodation, through investment in Extra Care Housing and Supported Independent Living, including:

- Expanding the development of Supported Independent Living by 500 units to reduce the number of people with learning disabilities or autism living in residential care by 40 – 50%.
- Delivering 725 new units for affordable extra care housing by 2030.
- Providing 185 210 units of Supported Independent Living accommodation for people with mental health needs.

Surrey County Council delivery

The delivery of the "Right Homes, Right Support" programme is progressing well with plans in place for 580 units of Extra Care Housing on Council owned land. One of the sites has secured planning permission and construction will start shortly, and a further 6 sites have secured outline planning permission. Sites have been identified for the delivery of Supported Independent Living accommodation.
