The Department of Health announces the 2007/2008 Extra Care arrangements

Extra Care Housing Fund 2007-2008

£40m is available for 2007 –2008 to develop new extra care housing places in England in areas where need has been demonstrated (as reflected in relevant strategies, particularly local Supporting People strategies and regional housing strategies) and which:

- a) Provide a significant and demonstrable health impact for older or other people with long term conditions
- b) Provide independent housing with access to on-site 24 hour support and care
- c) Contribute to the range of solutions to prevent unnecessary admissions into hospital or residential care; and/or assist in reducing delayed transfers of care from hospitals
- d) Demonstrate an inclusive approach as although the fund is primarily focussed on older people, bids for extra care housing for adults with long term conditions including learning disabilities, physical disabilities, dementia, mental health and other conditions are eligible for consideration

Timetable:

- July 2006 invitation to bid and supporting documents issued
- 3 October 2006 bids to be received by the Department of Health. Bids will be accepted electronically from Monday 25 September 2006 to midnight Tuesday 3 October 2006.
- Spring 2007 -results announced

Tier 4 Funding for drug rehabilitation services

Capital development programme for inpatient and residential rehabilitation substance misuse (drug and alcohol) services 2007/08 and 2008/09 - Application guidance notes

This document sets out the priorities and processes for capital development of inpatient and residential rehabilitation (drug and alcohol) services.

This guidance is to outline the strategic bidding process for resources to facilitate the capital development of inpatient and residential rehabilitation substance misuse services (collectively Tier 4) in 2007/08 and 2008/09 -see section 1.5. Definitions of these treatment modalities are detailed in ANNEXES 1 and 2.

The total capital fund available is £54.9 million. The capital will be allocated to Strategic Health Authorities with recommendations for spend based upon the outcome of a strategic bidding process.

This guidance is designed to assist Strategic Health Authorities and NTA regional teams in convening Regional Forums to inform their strategic role in assessing and prioritising bids as well as statutory and voluntary sector providers and Local Drug and Alcohol Partnerships in developing capital proposals.

Funding new Community Hospitals



The DH has made £750m available over the next years to PCTs to invest in new Community Hospitals. The arrangements are set out in guidance and in the accompanying policy paper, Our health, our care, our community: investing in the future of community hospitals and services. It states that £150m will be available

per year in each of the next 5 years for the development of a new generation of community hospitals. Details of the arrangements can be downloaded at www.dh.gov.uk.

New report from the Housing LIN Extra Care Toolkit

The Institute of Public Care is refreshing its guide on implementing and developing extra care strategies for the Housing LIN. The new toolkit is aimed at commissioners and providers tasked with producing an Extra Care Housing strategy. It offers a series of practical steps to develop local actions plans. Local authorities will find this helpful in finalising their bids, and also in the long term planning and development of Extra Care.

Homelessness and mental health services

Improving the Effectiveness of Rent Arrears Management for People with Mental Health Problems is a new good practice quide.

In June 2005, the Department for Communities and Local Government (formerly the Office of the Deputy Prime Minister) published guidance on 'Improving the Effectiveness of Rent Arrears Management'

The National Social Inclusion Programme decided it would be helpful to produce a briefing document which was specific to supporting people with mental health problems as they are thought particularly liable to accumulate arrears. The briefing document outlines why it is important for housing staff to support people with their mental health problems and the need for mental health staff to support people with their housing situation. It also shows in brief the key points from the DCLG guidance.

The report draws on the busing Conditions Survey





Housing and the Disability Equality Duty



This guide from the Disability Rights Commission explains the new rights and duties introduced by the **Disability Discrimination** Act 2005. which amended the 1995 Act. It outlines the duties of social and private landlords on making "reasonable adjustments" and goes

on to set out the requirements under the Disability Equality Duty which only applies to social landlords. Importantly, the guide offers a strategic approach to improving housing services for disabled people and how to comply with the new Duty. Indeed, the Housing Corporation have stated that they will expect and encourage housing associations to improve their own performance on disability equality.

Supporting People: Next Steps

The Department for Communities and Local Government have issued a brief summary of the preliminary conclusions from the consultation exercise undertaken earlier this year. <u>Supporting Independence: Next Steps in our Supporting People Strategy</u> sets out some key actions in relation to:

- more effective support and prevention
- a focus on the service user
- a focus on achieving outcomes
- funding issues (see grant allocation announcement below)
- ensuring effective administration
- supporting the voluntary and community sector
- e-supporting people

Supporting People grant allocations

The Department for Communities and Local Government has announced the final allocation of Supporting People grant to Administering Authorities for the year 2007-08.

We had already been advised last year that the total allocation for the year would be around £1.7bn. At that stage 95% of the total pot was allocated between authorities with the final 5% being held back pending consultation on the draft Distribution Formula.

Overall, the total pot falls just short of the £1.7bn and will come in at over £1,693 million. The redistribution of the remaining 5% portion has resulted in decreases of no more than 2% for 44 authorities, no change in 17 authorities, and increases for the remaining 89 authorities (with 5 authorities receiving the maximum increase).

RESEARCH UPDATE

Enriching Opportunities

This report, *Unlocking potential:* Searching for the keys, on the research undertaken by the Extra Care

Charitable Trust and the Bradford Dementia Group, attempts to better provide a step change in our thinking on the well-being and activity of people with dementia living in long-term care. It focussed on five key elements, including:

- specialist expertise in schemes, acting as a "locksmith"
- individualised assessments and case work to unlock people's potential
- levels of activity and occupation in the community
- staff training and skill development, and
- management and leadership to achieve sustainable outcomes

EXTRA CARE HOUSING PROJECT Raising the stakes: Promoting Extra Care Housing

Elderly Accommodation Counsel (EAC) has received an IGP grant from the Housing Corporation for new research on Extra Care Housing to be carried out in partnership with the Centre for Urban & Regional Studies (CURS), the Institute of Public Care and Peter Fletcher Associates.

The project, supported by the Housing LIN, aims to create a common platform of researched information about Extra Care housing for older people, commissioners and providers, so as to ground all stakeholders in a common understanding of what ECH can offer.

The project aims to deliver a series of specific and inter-linked outputs:

Making accessible a wide body of existing work, much of it commissioned by the CSIP Housing LIN and/or funded by HC IGP grant:

1. A comprehensive, practical and accessible online knowledge resource for commissioners and providers, providing detailed information on all aspects of commissioning, funding, designing, building and managing ECH

Drawing on and consolidating existing material, combined with new research designed to test the claims made for ECH and provide an evidence base for what appears to work well and what does not.

- 2. A **steps to success guide**, communicating an understanding of what has worked in schemes so far, for providers/commissioners and for residents
- 3. An **ECH appraisal tool** to assess success against objectives in current and future schemes

Focusing strongly on dissemination to all stakeholders, including older people themselves and their families

- 4. An industry-owned, independently-managed, **kitemarking** system to tie providers into agreed minimum standards and ongoing use of the appraisal tool and pooling of results
- 5. A series of targeted **communication tools**, including website modules, audiovisual productions and media presentations to introduce older people & their families, social care professionals and future care staff to ECH, the kitemarking and the ongoing learning process planned
- 6. A short, punchy **printed publication** to introduce all stakeholders to the above eg. "Making housing with care work a challenge and an opportunity for all of us"
- 7. **Further promotion & dissemination** to be devised with stakeholders during the course of the project.

Extra Care Housing Survey

The first step for the above project has been the dispatch to some 350 providers of a total of 750 questionnaires, asking for updates on details of schemes held on the National Database of Housing for Older People. Please make sure that your latest schemes are included in this survey.

CSIP Network news

Readers may not be aware that CSIP has four primary networks. These are for Housing, Telecare, Integrated Care and Better Commissioning.
