NEWS UPDATE - DH Extra Care Housing Fund

Minister announces Extra Care awards

Speaking at the Laing & Buisson Extra Care Housing conference today, Ivan Lewis, Secretary of State for Social Care announced 14 successful bids for the Department of Health's £40million 2007/2008 Extra Care Housing fund. The successful bids from authorities with social services responsibilities are a mix of new build and remodelled schemes.

The fund was oversubscribed by fourfold this year, with 43 bids submitted in total. There was close attention to the Department's White Paper, *Our health, our care, our say,* with specific focus on improved health outcomes, value for money, partnership, and strategic fit. POLICY UPDATE

Disabled Facilities Grants

On the 18th January the Department for Communities and Local Government announced a consultation on proposals aiming to widen the scope and improve the delivery of the Disabled Facilities Grant (DFG) by making the application process more flexible, easier and quicker.

The three month consultation follows on from recommendations made in an independent report on the DFG programme commissioned by the Government and undertaken by Bristol University.

The Government has made available £126m for the DFG programme in England for 2008-08, an increase of 5% on the annual amount for 2006-07.

Social Enterprise

Social Enterprises are organisations that are run along business lines, but where any profits are reinvested into the community or into service developments. Encouraging social enterprise in health and social care is a key part of the patient-led reforms.

In October 2006, the <u>Social Enterprise Unit</u> invited applications to be part of its social enterprise pathfinder project. The learning from the pathfinders will be shared across health and social care, so that others can benefit from their experience. The Government has today announced proposals for a new agency to deliver regeneration and housing in a major shake-up of the way it supports the delivery of new homes and develops mixed, sustainable communities in England.

The proposed agency - *Communities England* - will bring together the functions of English Partnerships, the Housing Corporation, and a range of work carried out by the Department, including delivery in the areas of decent homes, housing market renewal, housing PFI, housing growth and urban regeneration. 'Good Practice in involving service users'

The **Tenant Participation Advisory Service** (TPAS) are working with LIN to collect and share good practice examples from the housing sector about how service users are involved in influencing decisions about housing. LIN members will be contacted with a brief survey about your experience and you will be asked to provide any examples you have of good practice. TPAS will also contact organizations on it's database of contacts. TPAS need to establish 'what good practice is' what it actually



looks like for real as a bench mark to measure your examples against. To help with this process they are looking at the criteria others have for determining what good practice is eg Chartered Institute of Housing, Housing Corporation. They are also looking at guidance in the TPAS Pinpoint Quality Toolkit and the Key Lines of Enquiry used by the Audit Commission to help develop a framework of what good practice in involving service users in housing services should look like.

TPAS will be consulting a small reference group of service users to help with determining the good practice criteria from their perspective too.

It would help TPAS had a view from LIN members about what you think the criteria for being recognized as good practice should be.

Once TPAS have all this feedback the 'good practice' criteria will be finalized and the survey on the LIN website and to TPAS members asking for any good practice examples which meet the criteria provided be sent to TPAS to be included in a learning matrix to be shared with all LIN members. The Service user reference group consulted about the Good practice criteria will be consulted about the shortlist of examples presented for inclusion to check from a service user perspective that the examples do meet the criteria.

An Extra Care Housing Kitemark and a new ECH website

The Department of Health wants to see provision continue to grow, new providers entering the market and new models developed. But a prerequisite for a healthy market is that older people – the customers – feel they understand and can trust the product. That is why the Housing LIN is delighted at the progress being made within the Extra Care Industry Forum, supported by DH (through CSIP) and the Housing Corporation, towards a voluntary kitemarking system for extra care.

The work of the Forum is ongoing, but the indications are that its recommendations, to be put before the industry later this year, will focus primarily on information. A protocol will ensure that all providers of housing-with-care give a clear explanation of what their particular model comprises, what it aims to deliver in terms of results or 'outcomes' for customers, and how they measure the outcomes achieved in practice.

A kitemark of this kind would be something wholly different from the well developed codes of practice that already exist for sheltered housing, and the quality control of care services imposed by CSCI. It would help strengthen this new market by educating customers about what extra care has to offer, whilst demanding that providers prove that they deliver what they promise. UK Housing schemes for older people are among the very best in Europe

Three UK housing schemes for older people have received awards for best practice in design excellence across Europe.

The three winning UK schemes received awards from the prestigious WELHOPS (Welfare Housing Policies for Older People) project this month in a series of award ceremonies, while award winners in Europe received their awards in December 2006. See <u>www.welhops.net</u>.

The WELHOPS Steering Group from Italy, Spain, Sweden, Hungary and the UK examined 45 European housing schemes this year, awarding 12 in recognition of best practice and excellent design, 3 of which were British. All 12 schemes will feature in the WELHOPS housing design guide to illustrate good practice.

The three winning UK schemes are:

• Darwin Court, London - Peabody Trust

Darwin Court, in a deprived part of London, was seen a beacon of good housing for older people with its generous amount of community space, excellent IT facilities, swimming pool and roof terraces which made use of optimum space in a built up area.

• Sonali Gardens, London - Circle Anglia and London Borough of Tower Hamlets

Sonali Gardens showed how successfully cultural and faith needs can be met to create a happy atmosphere for staff, residents and the local community. Again, situated in a deprived area, Sonali Gardens still set high standards for its lifetime homes which were light and airy with good quality communal areas and much loved "Golden Gardens"

• New Larchwood, Brighton - Hanover Housing Association and Brighton & Hove City Council

New Larchwood is the most recently built of all three schemes, being completed in summer 2006. This impressive development incorporates the greatest range of accessibility and variety of communal areas, offering a café, shop, cinema for residents, library and a new GP surgery which serves the whole community.
