

# Forthcoming resources from the Housing LIN

The LIN has commissioned a range of new materials to support commissioners, providers and users of housing with care for older and vulnerable adults. These include:

- a review of Tier 4 funded services and supported housing for people with severe substance misuse
- a technical brief on charging arrangements in Extra Care Housing
- a review of practice of floating support services
- in conjunction with the Royal Town Planning Institute, an advisory planning note on planning for housing for older people,
- with Gateshead Primary Care Trust and the local authority working to hold a workshop to identify how telecare can increase independence for individuals with acquired brain injury, and
- three case studies; i) on telecare and working with community matrons; ii) on partnership working and commissioning Extra Care in Leicester; and iii) a review of Essex County Council's housing strategy for older people.

# **POLICY UPDATES**

# <u>Department of Health funding for Extra Care</u> Housing

I am afraid that we still do not have any news on the arrangements for the DH's £40m extra care housing fund programme for 2007/2008. As soon as details are available we will notify readers.

### **Independent Living Bill**

The Disability Rights Commission (DRC) has assisted Lord Ashley of Stoke in preparing an Independent Living Bill which will deliver stronger rights and entitlements to independent living for disabled people based on the principles of freedom, control, choice and dignity. The Bill will get its second reading in the House of Lords probably on the 14th July. This briefing explains why the Bill is needed and what it will do.

# <u>Housing Corporation consultation – tackling</u> <u>homelessness</u>

This consultation paper suggests how housing associations might work with the Housing Corporation and local authorities to respond to some key challenges including the number of households in temporary accommodation and improving access to affordable housing for rent. Views are sought on:

- how housing associations can support the development and implementation of local authority homelessness strategies
- how to improve nomination arrangements to build mixed income communities
- how homeless policies dovetail with choicebased lettings
- preventing homelessness
- working more closely with private landlords to access empty properties

# TELECARE UPDATE

# i) Register early for PASA Electronic Catalogue (NHS eCat)

High demand is expected for access to the NHS Electronic catalogue, which displays line details of all the NHS PASA national framework agreements. **Product lines for telecare will be available from 30 June 2006.** The electronic catalogue will list entries for equipment and services for use by a wide range of organisations that can access the National Framework Agreement for Telecare (further details are provided in the NFA update below).

Organisations not currently accessing NHS eCat in particular non-NHS services will need to follow the simple registration procedure and return a confidentiality agreement. It is important to register **NOW** as it could easily take up to two weeks to set up the appropriate user names. If you wait until 30 June to register, you may not receive your user name(s) until the week of 10 July.

For the agreement, we strongly suggest that the first named contact in any organisation is a senior manager, commissioner, procurement officer or telecare project lead who will be co-ordinating telecare purchasing activities and implementation.

# ii) PASA National Framework Agreement for Telecare - update

Over the past six weeks, the NHS Purchasing and Supply Agency (PASA) has evaluated the shortlisted suppliers for the telecare National Framework Agreement (NFA).

Commercial (Led by PASA) and technical evaluations (led by the Centre of Evidence-based Purchasing with input from CSIP and NHS Connecting for Health) have been undertaken on the offers received. PASA has now completed the analysis.

Prior to issuing the final recommendations to the Project Management Group established for this project, PASA held a Stakeholder Engagement Forum with a number of service organisation representatives on 23 May 2006 to discuss the outline recommendations to see if the proposed supplier offering would meet their needs. The group has provided positive feedback on the offerings presented, and the Project Management Group has agreed the recommendations brought forward at its meeting on 25 May 2006. The recommendations have now been signed off within PASA and the final recommendations have been approved by the Department of Health.

Suppliers are now being notified if they are successful or unsuccessful. PASA is then legally

required to follow the Alcatel procedure - this is a ten day cooling off period for suppliers to consider if they still want to be on the National Framework Agreement (NFA) or if unsuccessful suppliers wish to challenge the final recommendation. Following this period, successful suppliers will agree and sign up to the NFA, and the work starts on launching the contract, ensuring people can gain access to NHS-E-Cat (PASA Electronic Catalogue) to view the NFA and also on developing an information pack for users. Following these timescales as indicated previously, the NFA will be available for use by a range of organisations including local authorities, health trusts, housing associations, community equipment services and third sector organisations by the end of June 2006.

Continue to look out for special news alerts over the next few weeks on the National Framework Agreement and how organisations can access the catalogue. The catalogue go live date is currently scheduled for 30 June 2006.

# iii) Telecare is transforming patients lives - new publication from FHN and CSIP



On 14 June 2006, the Future Healthcare Network at the NNH Confederation and CSIP launched a report looking at how telecare can transform the lives of NHS patients by using new technologies to support people living in their own homes.

People living with long term conditions and the elderly are amongst those who will benefit

most from telecare initiatives.

The report predicts that as technology develops, telecare devices for disease management such as those that measure glucose, peak-flow, oxygen and blood pressure, will become as common as the TV set-top boxes you see in most homes today.

Through partnership working with health trusts, local government, the voluntary sector and other agencies, telecare is responding to the needs of an ageing population and enabling an increasing number of people to continue to live in their own homes.

At the NHS Confederation's Annual Conference, CSIP's Jeremy Porteus chaired a session with guest speaker Professor Heinz Wolff who demonstrated the pioneering work being carried out at Brunel University which puts simple daily living and health management ideas into practice using current technologies with user involvement.



# LEARNING DISABILITIES - UPDATE

# DH Extra Care Housing Fund for people with learning disabilities

The winning bids for £2.3m Extra Care Housing Fund 2005-2006 for people with learning disabilities were announced in March 2005. Details of these projects and contact names can now be found on our website under 'Learning disabilities' in the A-Z index

The 10 successful extra care sites are focusing on people who are living with older family carers. Most of the sites are using assistive technology in some form to support independence. Most of the sites are for younger people with learning disabilities. The models funded are varied.

# <u>Gadgets, Gizmos and Gaining Independence</u> – <u>Assistive Technology and people with learning</u> disabilities

This is one of the first studies of the potential of assistive technology specifically in relation to people with learning disabilities. It is intended to give real, practical advice and help. The report concentrates on readily available telecare to give more independence, and on devices to help communication addressing the needs of people with a learning disability.

The report answers some of the questions most commonly asked by individuals, families and workers directly involved in support or care. It looks at what different devices cost, where to get them, what different applications do and some of the limitations, also how to get the most out of some specialist software.

The report sets out a variety of ways of funding different types of assistive technology and concludes that unusually money should not be a barrier to gaining independence. It shows through seven case studies how assistive technology really can change the lives of people with learning disabilities sometimes in quite dramatic and unexpected ways.

One of the most commonly identified barriers to making assistive technology more readily available is uncertainty and inexperience in assessing and specifying assisted technology to fill this gap the report includes a model pro-forma to help this process.

# **Charging for Extra Care Housing**

The West Midlands Regional Housing LIN has commissioned independent consultants Angela Nicholls and Adie Kean to produce a fact sheet on Charging for Extra Care Housing. It is intended to inform commissioners and providers about the range of charging options available, and help them make decisions on charging appropriate to their local circumstances. It will also cover good practice in providing information on charges to service users.


