## MANAGING CHANGE

### HOUSING LIN DEVELOPMENTS

In April this year, the Housing Learning & Improvement (LIN) in the Change Agent Team was subsumed within a new Department of Health agency called the Care Service Improvement Partnership (CSIP). This move has both consolidated the Housing LIN's work programme under CSIP and enabled us to begin to broaden our "knowledge community" beyond Extra Care Housing (ECH).

While the Housing LIN will continue to deliver the learning support and practice exchange for the Department of Health's ECH programme for older people, the new CSIP arrangements will enable us to provide more tailored support across other client groups. This includes working closely with other programmes in CSIP such as the Valuing People Support Team, the National Institute for Mental Health in England and the Integrated Community Equipment Service (ICES) around the housing with care choices of people with a learning disability, mental health problems or accessing assistive technology and/ or telecare services to support independent living at home.

#### STAFFING NEWS

To support the above changes and enhance our current national and regional programmes, the Housing LIN is delighted to welcome Mike Clark and Denise Gillie to the team on a part-time basis. Mike joins us from the ICES Team and Denise joins from Durham and Tees Valley Strategic Health Authority (SHA). Denise will be familiar to some of you as up until recently she was seconded from the SHA to the Department to work on the ECH programme. Both Mike and Denise will begin our new Telecare programme and will contribute to developing the learning and service improvement strategies needed in advance of the DH's Prevention Technology Grant in April 2006 (see page 4 for more details).

At the time of writing, the Housing LIN is also recruiting for a Learning & Service Improvement Manager to take forward our work on housing with care for disabled people and specific support to extend the choices for people with a learning disability. We will focus on this programme in our next issue.

# DISCUSSION PAPER ON THE SINGLE ASSESSMENT PROCESS



# HEALTH RISKS AND INEQUALITIES IN HOUSING: AN ASSESSMENT TOOL

The Housing LIN launched this self-assessment diagnostic toolkit at the recent CIH/NHS Confederation conference, *Investing in Healthy Neighbourhoods*. It builds on work previously commissioned for the Neighbourhood Renewal Unit (NRU) in the ODPM on regeneration and health issues.

Developed by Professor Blackman at the University of Durham, the toolkit takes a person-centred approach to examine the specific health risks and conditions that impact on ones' housing circumstances. It is a useful companion for people undertaking health and safety checks under the new rating systems as well as those undertaking home visits, such environment health officers, health visitors, district nurses, OTs, home improvement agency case workers and other housing and/or support staff, to ascertain the health and well-being of their clients. For example, people who are homeless, lone parents or an older person.



This self-assessment toolkit is therefore designed to enable you to quickly:

- identify the issue
- assess what the extent of the problem is
- find where good practice is located
- audit how this is reflected in national and local policies and priorities, and
- determine what actions you need to take.

# **POLICY UPDATE**

There has been considerable policy development since our last *e-news*. The following is a summary of the major papers issued

 Independence, Well-being and Choice: Green Paper on Adult Social Care, DH

This sets out the government's vision for adult social care. It highlights a number of key housing related issues for further consideration and consultation. This includes references to Extra Care Housing, the further development of telecare services to support home based services and extending the use of direct payment. - The National Service Framework for Longterm conditions: DH

This NSF focuses on neurological conditions and the arrangements needed to provide the care and support to people living with long-term neurological conditions. It sets out a range of clinical and social measures to support people in hospital and in the community including quality requirements on providing equipment and accommodation (QR7) and on providing personal care and support (QR8). - Improving the Life Chances of Disabled People: Prime Minister's Strategy Unit

This report addresses the needs of all disabled people and the barriers they face and the adverse economic and social outcomes in the UK. It emphasises choice and control for independent living in a range of housing and related support settings as well as incentives for disabled people to get and retain employment. Excluded Older People: Cabinet Office/ODPM
 This interim report makes useful reading for those people interested in finding out how older people feel excluded from mainstream services.
 It provides up-to-date facts and figures on an ageing population and concise information on

key issues ranging from housing, equality and diversity to income and employment opportunities. It draws out the ways older people can be excluded and the resultant discrimination and disadvantage they may experience. ### **ECH GRANTS 2006-2008**

# PREVENTION TECHNOLOGY GRANT

In July 2004, as part of the Spending Review, the Chancellor announced £80 million funding for a social services' Preventive Technologies Grant over two years from April 2006. This is to extend the benefits of new technology 'community alarms', with the aim of reducing the number of avoidable admissions to residential care and hospital.

Guidance, with factsheets and toolkit, will be in launched in July 2005 at a national conference in London.

# PARTNERSHIPS FOR OLDER PEOPLE GRANTS

The Department of Health's Older People and Disability Division is leading a project 'Partnerships for Older People Projects' (POPP). The overall aim of the project is to test and evaluate through pilots 'new' arrangements for partnership working between health, social care and local government to deliver better, coordinated care for vulnerable older people in settings appropriate to their needs and wishes.

The pilots will be established during 2006/07 and 2007/08. They will have an outcomes focus and the strength of partnerships will be tested against agreed performance indicators. In particular:

- a reduction in avoidable, unplanned admissions to hospital for older people. This will include developing alternatives to hospital admissions and increasing the availability of preventative social services.
- an increase in the level of care in the community for older people to facilitate timely discharge from hospital and to support more older people.
- Identify incentives which ensure that funding can be released from across the system for reinvestment in community services.

# EXTRA CARE HOUSING FOR PEOPLE WITH LEARNING DISABILITIES

In March, the Department of Health announced the 10 successful bidders for Extra Care Housing for people with a learning disability. The successful bids were received by: South Tyneside, Redcar & Cleveland, Hartlepool, Dudley, Wakefield, Salford, Norfolk, Birmingham, Newham and Lambeth. # RESEARCH into MODELLING SHELTERED HOUSING and RESIDENTIAL CARE HOMES TO EXTRA CARE HOUSING

This 2 year Kings College Research project, supported by the Housing LIN and funded by the Engineering and Physical Sciences Research Council, seeks to examine how local authority and housing association sheltered housing and residential care homes have been remodelled to become extra care housing. This will involve architects, rehabilitation engineers and social scientists examining building to see how the remodelled schemes have been adapted, how successful this has been and what the problems are.

There will be ten case studies (5 local authorities and 5 housing associations) to examine a sample of sheltered housing schemes, which have been converted to extra care housing and residential care homes, with a focus on recent conversions. The research will involve studying before and after drawings and considering the implications for planning permission, building regulations etc. Interviews will be carried out with staff to see why the remodelling was done, any problems experienced and how they were overcome, how and why tenants were chosen (a sample will be interviewed) and what assistive technology was needed to cater for the increased frailty of the tenants. The architects for the ten schemes will be interviewed in order to analyse design-making process for each conversion. Members of the team will assess what other structural, engineering and innovatory technology might be needed in the future. The costs of the conversion will be calculated with the help of an economist. The end result will be advice for local authorities and housing associations.

#### **CARE & REPAIR ENGLAND**

This new self training guide *Providing housing* advice for older people – a self training kit for advisors, has been developed to help generalist advisers or anyone who works with older people to develop their knowledge and understanding of housing options for older people.

- It covers:
  - Informing and Advising: Understanding older people's housing needs and aspirations and enabling people to make informed decisions.
  - Is there a choice? What are the main housing, care and support options for older people
  - How do I find out what housing and services are available? An introduction to national sources of data and taking a strategic approach to building a local database
  - Knowing your limits: Finding specialist help and advice

# ACCESS AND SYSTEMS CAPACITY GRANTS and HIAs

Foundations, the national co-ordinating body for Home Improvement Agencies, undertook a survey last year on the DH's Access and Systems Capacity Grant (ASCG) and HIAs. Key findings from this survey were:

- two-thirds of respondents (101 agencies) had received ASCG in 2003/04
- about 79% of the ASCG to Social Services Authorities was allocated to HIAs
- the ASCG was used to fund hospital discharge schemes, falls prevention schemes, and projects that prevented or reduced hospital admissions.
