NEWS ON EXTRA CARE HOUSING

The Department of Health 2005-2006 funding round

The Department of Health (DH) have released details for making bids for the Extra Care housing funding in Year Two of the Access and Systems Capacity Grant programme.

In 2004/05, £29million was allocated together with a pre-allocation of £17.7million. For 2005/06, the remaining £40.3million has been allocated, including £2.32million for adults with learning disabilities.

Information on the bidding criteria for social services authorities and their partners, the bidding documents/spreadsheet and other supporting material are available on the DH's Housing Learning & Improvement Network (LIN) website at www.changeagentteam.org.uk/housing.

Key dates to note:

October 2004 – bids to be received by the Department of Health January 2005 – bid approvals to be announced

To provide greater consistency across all bids this year, bids should include the following:

- a coherent structure with index
- a summary sheet with a details of the bid, bidding partnership and contact details
- a project delivery plan approved by project partners
- undertake to start on site before 31 March 2006
- confirm other capital funding sources required
- confirm that nomination agreements are agreed with partners
- confirm that adequate revenue funding is committed
- reference to local strategies and plans
- additional information including if possible architects plans (contd. on page 2)

Housing Corporation approvals 2004/06

The Housing Corporation has announced that it is funding 45 new Extra Care schemes via its annual development programme totalling 1432 units. This programme does not include HC/DH joint funded schemes or those funded through the DH Extra Care programme.

DEVELOPING A CODE OF PRACTICE

In recognition of the variety of descriptors for Extra Care Housing (also known as very sheltered housing), the Department of Health is working with a consortium of policy makers and social housing, private sector and care providers to develop an overarching code of practice for Extra Care housing. This work will draw on existing regulatory and performance assessment requirements such as:

- the Housing Corporation at www.housingcorp.gov.uk
- Supporting People Quality Assessment Frameworks at www.spkweb.org.uk
- the new Annex on Extra Care Housing in the Code of Practice for Sheltered Housing developed by the Centre for Sheltered Housing Studies at www.cshs.co.uk
- the Association of Retirement Housing Managers at <u>www.arhm.org</u>
- the Commission for Social Care Inspection at www.csci.org.uk

The aim of this work is to provide greater clarity for older people making an informed choice about their housing with care options, as well as for the sector as a whole concerned about the over regulation and inspection of Extra Care housing. We intend to make further announcements on progress in the autumn.

MAKING BEST USE OF THE HOUSING LIN

A view from Southampton

Heather Christiansen, Community Care Officer at Southampton City Council writes, "The Housing LIN really does deliver its promises; in this case it was about meeting its aims and objectives of sharing what works and to facilitate good practice in local settings.

In Southampton we are monitoring and evaluating the extra care project based in one of our sheltered schemes to help us identify what will or will not work locally. We identified a dilemma

when we considered what policy approach we should adopt for a surviving spouse/partner who does not need extra care housing but who is left living in specialised accommodation and not needing it.

We posted a question on the Housing LIN Discussion Forum and received over 25 responses. The level of response demonstrated the support and advice people and organisations are happy to share with others. The views and suggestions and indeed some existing policies will help shape the policy approaches in Southampton.

Finally, I would like to say that the discussion has helped me tremendously in further formulating and reviewing my thoughts and views on extra care. A big thank you to the Housing LIN too for pulling a lot of the material together."

LATEST CASE STUDY REPORT AND FACTSHEETS

Achieving success with extra care housing

This case study report for the Housing LIN by Contact Consulting draws on the experience of providers of Extra Care Housing, tested against the experience and perspectives of commissioners and those responsible for developing local housing and older people's strategies. It can be downloaded at

The study began prior to the implementation of the Department of Health's (DH) Extra Care Housing funding programme but highlights a number of good practice points and obstacles to achieving success in the development of extra care schemes for older people. These will be extremely useful in this year's DH bidding round as well as accessing other future capital funding opportunities eg grants, private finance/loan arrangements.

Clearly set out, the case study outlines the key determinants for success. This includes the need for a strategic fit, a knowledge of the product/market, good relationships/partnering amongst all stakeholders, land and design issues, costed revenue and capital financial

modelling, and the outcomes to be achieved to support the independence of older people.

Factsheet no. 6 - Good design

On 17 May 2004 at the Designing for Old Age conference in Manchester, the Housing LIN launched a new factsheet on design principles for extra care housing. Produced by PRP Architects, it gives basic information about the key design principles and issues to consider when designing and developing a brief for a new extra care housing scheme. The factsheet can be downloaded from our webpages along with other factsheets in the series.

Factsheet no. 7 - Involving the private sector

On 24 June 2004 at the Association of Retirement Housing Conference (ARHM) in Malvern, the Housing LIN launched its factsheet on developing greater participation and involvement with the private sector. Produced by the ARHM, the factsheet seeks to forge closer links between commissioners of housing with care and the private sector and provides the framework for developing sustainable partnerships in the light of this year's DH extra care funding round.
