BREAKING NEWS

Over 200 bids received

Following the Minister's announcement in August 2003 of new capital funding for Extra Care housing, some 127 Social Services Departments throughout England have submitted 205 bids to the Department of Health, totalling £310.4 million, for the £29 million available for 2004-05.

Single bids range in value from £39,000 to £6.6 million, whilst multiple submissions range from 2 to 15 bids.

We hope to be able to give a more detailed breakdown of the bids in the near future.

The number of bids received demonstrates the important role Extra Care housing has in expanding the range of housing, care and support choices and well-being of older people, and its vital contribution within local care economies.

The Department of Health will announce the final bid approvals on 6 February 2004.

The bidding documents for the £58 million to be spent in the financial year 2005-06 will be available in August 2004.

The Housing LIN was established in November 2002 under the auspices of the Health and Social Care Change Agent Team at the Department of Health. It works alongside two other Learning Improvement Networks on Hospital Discharge and Intermediate Care.


