# NEWS UPDATE

### Getting Personal - Putting People First

On 10 December, the DH announced a £520 million Social Care Reform Grant over the next 3 years to transform care and independent living for older and disabled people through the introduction of personal care budgets and a concordat between central and local government, NHS and Social care. For further details see our policy news section on p2 of this enews.

### More Extra Care Housing funding forthcoming

The Local Authority circular LASSL(DH)(2007)2 accompanying the Social Care Reform Grant also highlights a number of specific revenue and capital programme that the DH will be taking forward to enhance independent living opportunities for older people. This includes a further £80m grant programme for extra care housing over the next 2 years, approx £40m per annum. Further details of the bidding arrangements are expected in early 2008.

### POLICY NEWS

#### Transforming Social Care - Putting People First

On 10 December Health Secretary Alan Johnson announced an extra £520 million of ring fenced funding to transform Social Care over the next three years through the introduction of Personal Care budgets.

The extra £520m will be allocated to councils as a Social Care Reform grant over the next three years. The grant is worth £85m in 2008/09, £195m in 2009/ 10 and £240m in 2010/11. It also includes some NHS resources in recognition of the impact social care can have on improving people's health and wellbeing.

The new concordat set out in *Putting People First* identifies the following elements that will be central to transformed local services:

1. The vast majority of people who receive funded care using their own personal budgets so they can decide which support services they want. An increasing number supported to use direct payments

2. High quality care homes, homecare and day services to be rewarded. Poor performers failing to respect people's dignity to no longer be used by local councils and the NHS

3. First-stop shops offering information, advice and advocacy to help people, irrespective of their means, choose care for themselves or a family member

4. Local councils and voluntary organisations taking joint responsibility for tackling loneliness and isolation amongst older people

5. Carers to be treated as equal partners and experts by professionals. New specific support for carers will be announced by the PM in spring 2008.

6. Assessments and paperwork to be streamlined so social workers are able to spend more time on the frontline and less time with their computers

7. Co-located services, e.g. social workers based in primary health centres alongside GPs and nurses

8. A network of 'champions' in every community promoting dignity for older people

9. Inter-generational programmes bringing older and younger people together in schools, day centres and neighbourhood housing schemes

10. New technology to be at the heart of ensuring people can remain in their own homes and live independently.

#### Supporting People funding news

The CLG announced £4.9bn funding for the Supporting People programme over the next three years last week. The funding will help over a million vulnerable people each year, including victims of domestic violence, teenage parents, older people and those with mental health problems - enabling them to live independently in their accommodation. Supporting People funding will total £1.686bn in 2008/2009, £1.666bn in 2009/2010 and £1.636bn in 2010/11. #### National Housing Strategy for an Ageing Society

This is now due to be launched in early 2008. To accompany the strategy, the Housing LIN is working on a toolkit to support commissioners and providers develop local strategies as well as a sector specific Information Resource Pack for providers of housing, care and support services for older people. #### World Class Commissioning

The Department of Health is transforming the commissioning health and care services in the NHS to drive unprecedented improvements in patient outcomes. It has worked with commissioners and their partners to develop a vision for world class commissioning and a set of 11 organisational competencies.

Delivery of this vision will take place within an assurance system. This will improve performance and development, and reward commissioners as they move from their current position towards world class standards.

#### Establishing LINks - engaging with local communities

The Local Government and Public Involvement in Health Act 2007 introduces important new measures

relating to local government and the involvement of local communities, including commissioners and providers involved in the delivery of services for older and vulnerable people.

Backed up by £84 million over three years, LINks will make it easier for communities to influence key decisions about local health services and hold those services to account. Run by local people, each LINk will cover all the publicly funded health and social care services in a local Authority area - irrespective of who provides them. LINks will:

- aim to represent everyone in the community not just existing activists but also those not currently being heard.
- have the power to investigate issues of concern, demand information, enter and view services, make reports and recommendations, and refer issues to local councillors;
- provide a one-stop-shop for the community to engage with care professionals and vice versa.

In addition, the legislation changes the existing duty to consult by clarifying the notion of a 'significant' change to services, so that NHS bodies know when they should consult. It also gives PCTs a new Statutory duty to respond to local people, explaining the activities they are undertaking as a result of patient and public feedback on their services.

#### Valuing People now: from progress to transformation - a consultation on the next three years of learning disability policy

Care Services Minister Ivan Lewis launched a consultation to seek views on the priorities for learning disability for the next three years.

Valuing People Now - From Progress to Transformation' is a cross-government consultation, which sets the agenda across a range of issues, including health and well-being, housing, employment, education and community inclusion.

It builds on the vision set out in Valuing People (2001) which was the first white paper on learning disability for thirty years - a vision based on the four main principles of rights, independence, choice and inclusion.

### CAPITAL FUNDING NEWS

#### Learning Disability Campus Programme

The White Paper ' Our Health, our Care, our Say' said that NHS residential accommodation (NHS Campuses) should be closed by 2010.The Department of Health is providing some targeted support to meet the Government's objective to move people with learning disabilities from NHS campuses to more appropriate accommodation in the community.

The second stage of bidding for capital under this programme has now opened. Total funding of £175m is being made available to PCTs over three years to 2009-10, to help with the reprovision of people living in NHS campuses. The closing date for applications is noon Friday 25 January 2008.

#### **Disabled Facilities Grant**

Thousands of older and disabled people will benefit from extra Government funding for home adaptations, such as ramps, stair lifts and easyaccess showers. Communities Minister Baroness Andrews announced the increases in the Disabled Facilities Grant (DFG) as part of a package of measures designed at helping people live independently in their own homes for longer.

The DFG will increase by £25 million for 2008/09, a significant increase of 20 per cent, taking central Government funding up to £146 million. Central government funding for DFG has already doubled since 1997 from £57 million to £121 million this year.

The Government also announced plans to strengthen Home Improvement Agencies (HIAs), the locally based not-for-profit organisations that help homeowners and tenants renting private housing repair and maintain their homes. # CLG announces £70m hostel grant - Places of Change

In November, Yvette Cooper, the Housing Minister, announced a new £70 million capital to help rough sleepers make a permanent move away from the streets. The investment will fund more than 100 new or upgraded hostels with training facilities to help some of the most vulnerable people in society move on to independence.

The new type of hostels provide on-site training for residents to learn practical vocational skills from catering to sound engineering, and setting up social enterprises.

#### Dementia Care Partnership: More Than Bricks and Mortar

This Case Study on the work Dementia Care Partnership (DCP) in Newcastle has a number of features which make it distinctive - possibly unique - and well worth emulating. A complementary range of services for people with dementia and their carers enable individually tailored provision. An underpinning value base commands a high level of commitment from staff and volunteers.

With an emphasis on independent living and individual fulfillment, people with dementia and their carers play a significant role, not only in determining their own support, but in shaping what DCP does. DCP has been awarded "Pathfinder status" by the Department of Health's Social Enterprise Unit and will be going on to develop a series of social enterprises. This case study describes DCP's services and approach.

# Comparative evaluation of models of housing with care for later life

This Joseph Rowntree Foundation publication studies seven different housing with care schemes for older people in England.

A growing number of housing schemes for older people combine independent living with relatively high levels of care. However, there are questions about what, if any, model works best for older people. The authors examine how different models of housing with care address the needs of older people.

The longitudinal study compares seven different housing with care schemes, including 'village' style and smaller schemes operated by a range of provider organisations in different locations. It considers:

- what makes schemes distinctive;
- services and resources; and
- how different needs for housing, care and support are balanced.

# Towards Lifetime Neighbourhoods: Designing sustainable communities for all

This discussion paper by the International Longevity Centre and the CLG was produced as part of the development work behind the forthcoming National Strategy for Housing in an Ageing Society.

Many of us are aware that we live in an ageing society but the impact of these changes is often narrowly framed within a specialist, welfare, health or social care-based perspective. It is unusual for us to consider how neighbourhoods should respond to older people's experiences in the wider, 'day-to-day' built environment. This paper looks at what constitutes "lifetime neighbourhoods" and the relationship with sustainable communities for all.

#### <u>Report of a legal judgement - Lewisham London</u> <u>Borough Council v Malcolm</u>

The Court of Appeal has held that where a local authority seeks possession against a disabled person who has lost security of tenure under the Housing Act 1985 for a reason relating to that disability the court must dismiss the claim for possession if satisfied that the claim is unlawful under the Disability Discrimination Act 1995.

#### Promoting Independence Self-Assessment Tool

The White Paper "Our health, our care, our say" emphasises the need for health and local government to make a shift towards promoting independence, prevention and early intervention. Subsequent guidance on commissioning for health and well being and the new national set of indicators have strengthened this focus.

This tool from the DH Partnership for Older People Pilots allows local authorities and health communities to work out their strengths and areas for further work on this agenda. It can be downloaded and used as a tool within a system, with or without external facilitation. It can be a very effective tool for working out the priorities for the older people's dimension of Local Area Agreements.

#### Predicting who will need costly care

This new study from the Kings Fund suggests that as the population ages, the prevalence of complex conditions requiring intensive social care will increase to a point where the costs are difficult to sustain. To avoid this crisis, it states that preventive 'upstream' interventions should be targeted at those people at lower, emerging risk. Evidence suggests that these interventions could avoid future admissions to care homes. The study argues that an assessment tool could be developed to effectively focus resources and preventive measures in tackling this problem and highlights a number of models to support early interventions across housing, health and social care.

#### **Reviewing Nomination Arrangements in ECH**

The Housing LIN has commissioned Trimmer CS (Housing Consultants) to undertake research into nomination arrangements for extra care housing. They would like to hear from providers, housing authorities, social care commissioners and service users about their experience of nomination arrangements in ECH, and identify examples of innovation and good practice. The results will contribute to a forthcoming fact sheet, which will be available through the Housing LIN.

Areas of particular interest include:

- Tensions (and how to resolve them!) between Housing and Social Services priorities – the linkages between case management and housing nominations
- Maintenance of balanced communities in ECH

On 29 November 2007, The Personal Social Services Research Unit (PSSRU – University of Kent) held a feedback seminar on the initial findings of their evaluation the Extra Care Housing Schemes funded by the Department of Health Extra Care Housing Initiative. The full report is expected next year.

PSSRU is a Department of Health funded research centre with a long history of research in the field of care homes for older people. It is developing a programme of research on Housing with Care to investigate alternative settings to care homes, their characteristics and how they affect older people in need of care and support. #### New extra care schemes:

A new Extra care scheme funded by the Department of Health and the Housing Corporation opened on the 14<sup>th</sup> November at St Paul's Court Efford, Plymouth. It has been developed by Ridgeway Community Housing Association. The scheme includes 40 one and two bedroom apartments and benefits from 24 hour care staff providing personal care and support tailored to individual needs.

Guinness Care and Support are aiming to open the first Extra Care scheme for Black and minority ethnic elders in Bristol. The regional meeting of the SW LIN planned to take place in March may be held at this new innovative scheme.

#### New strategies/reports:

As part of the SW LIN's ongoing IGP funded project "Assessing regional housing markets and developing effective strategies for meeting older peoples housing demands regionally" A group of key people are meeting with the aim of promoting leadership, Innovation and Good Practice in Housing. Anticipated products of the programme include (1) an "Advisory Note" for regional policy makers to "age proof" housing, investment and commissioning strategies, and (2) a resource pack for housing, care and support providers.


