NEWS: Extra Housing to Support Independent Living

Speaking at the regional dignity road show in Barnsley on 21 July 2008, Ivan Lewis, Minister for Social Care at the Department of Health announced the 25 successful Extra Care Housing bids for the 2008-2010 £80m grant round.

Working closely with the Housing Corporation and CLG, he highlighted how these new schemes will supply over 2,000 new units of extra care housing for people with a variety of long-term conditions, social care and housing need.

The authorities with adult social care responsibilities include a mix of unitary and two-tier authorities as listed below:

POLICY NEWS

Lord Darzi Review of the NHS

To coincide with the NHS's 60th anniversary, Lord Darzi has set out proposals in *High quality care for all*, his final review of the NHS, that will give patients more choice and information, reward the hospitals and clinics that offer both the highest quality of care and provide the most responsive services, including tackling health inequalities and references to "broader factors such as poor housing".

It sets out a vision for an NHS and how it will:

- Give patients more information and choice, including:
 - * 5000 patients with complex long-term conditions will pilot new personal budgets.
 - * Personal care plans for all 15 million patients with a long-term condition.
- Help people to stay healthy, as well as treating them when they are sick.
- Enable frontline staff to initiate and lead change that improves quality of care for patients:

Approvals made on LAAs

Approvals for the local priorities contained in the 150 new local area agreements (LAAs) were reached at the end of June. Out of the total of 5,813 indicators chosen by localities across England, 2,750 either contribute or are determinants of health and well-being.

New monies to support stroke strategy implementation

Local authorities and Strategic Health Authorities will share funding from a new government commitment to spend over £77m over the next 3 years to help deliver the goals set out in the national stroke strategy. Evey LA in England will receive a grant worth an average of £100,000 per year to aid the delivery of local stroke services and each SHA will receive £2.4m over 3 years to invest in improvement to acute services, including better access to rehabilitation.

On the 19th June, the dementia strategy consultation paper, "Transforming the Quality of Dementia Care" was published.



TELECARE/TELEHEALTH UPDATE

White Paper Whole System Demonstrators Action Network (WSDAN)



The Department of Health commissioned White Paper Whole System Demonstrators Action Network (WSDAN) was launched on 9th July 2008.

CSIP Networks and the King's Fund will be maintaining the new network for the Department bringing together a wealth of knowledge and expertise.

WSDAN brings together the evidence associated with assistive technologies such as telecare and

telehealth in integrating care for people with longterm conditions and also supports 10-12 action research partnerships.

CSIP Networks Programme Lead, Jeremy Porteus said "The Care Services Improvement Partnership is delighted to be a partner in this innovative, new network with the King's Fund. For the first time, commissioners and providers can come together to address the health, care and support needs of their populations with long term conditions, identify lessons learned from the demonstrator sites in Cornwall, Kent, Newham and start making improvements to transform their local services".

<u>Duddon Mews Extra Care Scheme for People with Mental Health Problems and Physical Frailty in Cumbria</u>

This case study describes a small extra care scheme and day centre in Millom, Cumbria, targeted primarily at older people with dementia. The case study adopts a "critical friend" approach, outlining various aspects of the scheme – development process, physical features, on-site service provision, eligibility and finance – and explores some of the pros and cons of the approach adopted at Duddon Mews. It is likely to be of interest to others developing or providing housing with care for people with dementia.



Safeguarding Adults and housing

The Department of Health, together with the Home Office and the Ministry of Justice, are launching a consultation on the adult protection guidance called 'No Secrets' this autumn. The document is called "Safeguarding Adults" and invites a debate on the wider safeguarding responsibilities of local authorities, housing departments, the NHS, the police, the courts and social care. It notes that many vulnerable people live independently in the community, often without social care support. One of the questions it poses is: How can housing providers contribute to safeguarding? What could housing departments, housing associations and supported housing/living providers do to enable their tenants and residents to live safer lives?
