#### **NEWS:** New £96m Revenue Funding for the Campus Reprovision Programme

People with learning disabilities are to benefit from £96 million in Government funding that will help provide them with better healthcare, community support and employment prospects. The revenue funding, ring-fenced for three years from 2008/09 until 2010/11 will pay for costs incurred as a result of people with learning disabilities moving from campuses to housing in the community.

This will include support for health action planning, workforce training and development, advocacy support for more inclusive community based activities and help to get people into employment.

This follows on from the £175 million announced last year for Primary Care Trusts to help with the capital costs of closing institutional NHS accommodation and providing more appropriate community arrangements for those with learning disabilities.

This new and improved accommodation will give people the opportunity to develop important social skills and the freedom to make everyday decisions.

Care Services Minister Ivan Lewis said:

"This funding opens the door to a better way of life for hundreds of people with learning disabilities, who will now be able to integrate into communities across the country, while given high quality support to lead a full life as equal citizens.."

The successor to the Housing Corporation, the Homes and Communities Agency (HCA) will come into being from 1 December 2008. More details on this in our next e-news but, under statutory arrangements contained in the Housing and Regeneration Act 2008, the HCA will now also "contribute to...good design in England with a view to meeting the needs of people living in England" and defines good design as that which "has due regard to the needs of elderly persons and disabled persons".

It includes a new core dataset which provides a list of indicators what can assist partners in preparing their JSNA, with key information on each indicator, and offers readers the chance to choose specific levels of detail.

#### The website:

- early identification and involvement of key stakeholders – including older people and other tenants
- Pulls together existing information and documents on JSNA
- Provides tools and resources to support the implementation of JSNA
- Offers links to other websites related to policy and guidance.

The Housing LIN are funding the SW Public Health Observatory to produce a JSNA and housing toolkit to aid strategic planners and commissioners better understand the housing needs of their local populations. Details to follow in a later enews.

### Housing LIN's response to consultation on the National Dementia Strategy

The dementia strategy is due out from the DH shortly. In its response to the draft strategy, the network praises parts of the document but says that it risks missing opportunities to achieve strategic outcomes for some people through housing sector services and the independent sector. It says these could prove cost-effective.

The Housing LIN will be producing a briefing on the strategy and key housing aspects for our next enews.

### 'Firststop' a New Advice Service for Older People, Their Families and Carers

The 2005, Office of Fair Trading (OFT) report called "Care homes for older people in the UK. A market study" highlighted a lack of awareness among older people about information sources, confusion about rights, a lack of transparency on pricing of care home fees and avenues of redress. The report recommended that the Government should establish a central information source or one-stop-shop for people to get information about care for older people.

FirstStop, an initiative of four partner organisations: Counsel and Care, Elderly Accommodation Counsel, Help the Aged and NHFA Care Fees Advice is designed to address this issue – and more. It gives advice and information on all forms of care and housing options for older people, and as FirstStop develops it will localise its services by weaving in local partners, providing access to face-to-face delivery, support and advocacy.

One of the main features of FirstStop is that callers will only have to tell their story once. An online customer management system allows all four partners to access client records and input to the advice and information process to meet all the caller's needs.

#### **New Report**

#### Rainy Days, Silver Linings

Using home equity to fund care is studied in a guide published this month by CSIP Network's Housing Learning and Improvement Network. Rainy Days. Silver Linings looks at both social and political attitudes towards equity release and its use in funding care and the products currently available. It warns that the current downward pressure on housing prices should not prevent a debate because history shows that the market grows steadily over the longer period – providing significant equity for millions of people.

The report draws on research which shows that when the housing market was rising people showed interest in equity release products but were largely hostile to the concept of using the money released to fund care in old age.

Jeremy Porteus, National Programme Lead for CSIP Networks, said: "Policy decisions in this area will affect the care experiences of millions for decades to come, the housing market and lifestyle choices. The trend over the last half century has been a strong rise in housing prices and therefore equity. We cannot let a temporary cooling of the housing market freeze the debate."

#### Home Equity can personalise services

Equity release can allow older people greater choice and control over their retirement housing, a report launched this month concludes.

The Aspiration Age research project, led by One Support (the care and support arm of One Housing Group), researched and tested three equity based products.

These included using equity release to fund care and support and housing associations taking an equity stake in both specialist and private homes in return for services.

As well as finding that equity schemes increased

the options open to older people with care needs, the project identified a key role for housing associations and extra care housing. The latter offers a viable alternative to residential care, the project concluded, as it allows older people to continue living independently while accessing changing levels of care and support in response to their needs.

### <u>Improving Practice in housing for Drug Users – A Partnership Project</u>

A comprehensive and integrated approach is central to successful housing support for drug users, a paper containing 13 case studies suggests.

The main focus of this paper is a selection of 13 case studies offering examples of how housing, drug and mental health services have worked together to find sustainable and successful housing solutions for drug users. This paper is aimed primarily at informing and helping those involved in commissioning, planning and delivering:

- housing
- housing services
- related residential rehabilitation
- support services for drug users

It will also be of interest to anyone working with drug users with related housing needs through the criminal justice system, health and social care (hospital and community-based services) or those working with vulnerable groups.

By adopting such an approach, local areas can help prevent homelessness, reduce crime and anti-social behaviour, as well as helping service users tackle their drug use and improve their health and social well-being.

The paper also brings together supporting information such as relevant national strategies, policies and guidance, national, regional and local delivery structures.

Both providers and commissioners took part in the survey so that common ground could be identified and learning from the experiences shared by all parties. The recommendations focus on issues of shared concern including timetables, accommodation and support links, transfers of services and TUPE, tender documentation and communication.

## Don't stop me now: preparing for an ageing population

This report from the Audit C o m m i s s i o n emphasises that councils have a local area leadership role to ensure that older people can live independently and actively, with a good quality of life, for as long



as possible. It suggests that most councils should do more to create an environment in which people thrive as they age. It stresses that they need to engage with older people in commissioning, designing and delivering mainstream and targeted services to tackle social isolation and support independent living.

There are some specific case studies and examples of how housing can be improved to support independent living.

#### RESEARCH UPDATE

### <u>"Living and Caring? An Investigation of the experience of Older Carers"</u>

This research from the International Longevity Centre uses the 'English Longitudinal Study of Ageing' to explore the lives of different groups of older carers in relation to multiple factors such as health, income and quality of life. The key findings of the research include:

- Older carers providing 'heavy' care show a markedly lower quality of life compared to equivalent non-carers.
- More than any other characteristic, including general health and experience of pain, it is the memory functioning of individuals

receiving care that has the biggest influence on the quality of life of older carers.
