

# <u>Putting People First – new circular on transforming care</u>

The DH Local Authority circular, published on 5th March 2009, sets out information to support councils and their partners in the ongoing transformation of adult social care as set out in 'Putting People First: a shared vision and commitment to the transformation of Adult Social Care' (2007). It includes key objectives for Putting People First to transform the delivery of social care and provide care closer to home. In particular, it reinforces the details of how the ring-fenced Social Care Reform Grant should continue to be used to help councils redesign and reshape their systems over the remaining 2 years of the Grant. The circular identifies a number of areas of delivery around personalisation, prevention and early intervention, integration and partnership working at a local and regional level, such as the work of the Joint Improvement Partnerships, Regional Improvement and Efficiency Partnerships and Joint Strategic Needs Assessments.

Whilst there is not an explicit reference to housing, it does cite care closer to home and independent living as key priorities. For information on the strategic links to housing with care, see the recent Housing LIN briefing, Transforming the Delivery of Services, at:

# <u>Supporting People and Area Based Grant</u> allocations 2009/2010

CLG has published details of how the £1.66 billion of Supporting People funding will be allocated amongst local authorities in 2009/2010. As reported in the previous Housing LIN enews, the Supporting People funding is un-ringfenced from 1 April 2009 and will become part of Area Based Grant from 2010.

### DH announces 3rd sector grants allocations

A number of housing and housing related agencies have been awarded DH Third Sector Investment funding for Innovation Excellence & Service Development. These include:

### Informing decision making - housing and health

Care and Repair England have been awarded a grant for their *If only I had known...* programme. The aim is to help older people, their families and carers to make informed decisions about future housing, care and support either following hospital admission or where a person has a long term health condition.

### Care advice improvements for the 21st century

Elderly Accommodation Counsel (EAC) has received a 3 year grant to 'lead a step change' in the way older people can access the highest quality information and advice on their care choices. The work will extend the scope and functionality of EAC's current website so that older people have easy access to a 'trusted' site with the latest up-to-date information on housing and care in their area.

### Linking homelessness and health

Homeless Link, the national umbrella organisation for homelessness agencies in England, has been awarded funding to deliver a project to improve access to healthcare for homeless people. The project will develop an audit tool which will enable agencies to evidence the health needs of a group often marginalised from mainstream healthcare, which as a result experiences acute health inequalities. The evidence provided by the audit tool will enable agencies to inform commissioning of future services, through local strategies such as the Local Area Agreement (LAA) and Joint Strategic Needs Assessment (JSNAs).

#### Falls prevention – taking extra care

The ExtraCare Charitable Trust have been awarded funding to run a pilot to reduce the number of fractures sustained as a result of falling by residents living in schemes and villages. Residents will be offered an annual risk assessment for undiagnosed osteoporosis to enable preventative treatment and early intervention to be tailored to the individual and their lifestyle.

## <u>Supporting People: Select Committee</u> Announcement

The CLG Committee has decided to undertake an inquiry into the Government's "Supporting People" programme. The Committee is inviting written submissions on the programme, particularly on the points raised below.

The Committee's inquiry will consider the extent to which the Government has, so far, delivered on the commitments it made in Independence and Opportunity: Our Strategy for Supporting People. The Committee will also consider the implications of the removal of the ring-fence, asking what needs to be done to ensure that the successes of the programme so far are not lost, or services cut, following the change; and what opportunities this change in the funding mechanism will offer for innovation and improvement in the delivery of housing-related support services.

Guidelines on submitting evidence. Each submission should:

- be accompanied by a covering letter containing the name and contact details of the individual or organisation submitting evidence,
- begin with a short summary in bullet point form; and
- have numbered paragraphs.

# Marketing Extra Care Housing - getting it right

This comprehensive report by Michael McCarthy provides an insight into how extra care housing is marketed – to consumers, funders, planners, commissioners, other key stakeholders and to the community. It examines what we mean by a 'market' The report explores the techniques deployed by Extra Care Housing (ECH) developers/providers in the marketing of ECH across all sectors, establishes what providers view as 'successful' marketing and how they gauge this and assess and review performance and determines which factors/criteria/ conditions make for effective marketing.

It also describes the tools/resources/knowledge/assets/personnel/training deployed, identifies good ideas and best practice and sets out a strategy for wider dissemination and education to ease/lower barriers to market entry. It includes examples of failed marketing and assesses lessons learned, including areas of 'Marketing Deficit' where the case for ECH has not been made. It also sets out how marketing can adapt to recession and the credit crunch.

# Joint Strategic Needs Assessment and Housing: Report of a study based on the South East region

<u>This report</u> was commissioned by the Department of Health South East, the Department of Health's Housing Learning and Improvement Network (LIN) and the South Central and South East Coast Strategic Health Authorities.

The report is based on a study of documents produced in the South East of England as part of the Joint Strategic Needs Assessment (JSNA) process and examines the extent to which housing needs are covered within the JSNAs produced during 2008. The report includes key themes relating to housing needs and suggests ways to increase housing coverage, which we believe local areas may find helpful in future development of the JNSA.

# The Future of Regulation for Health and Adult Social Care in England

Published by the DH in March, this includes a response to the consultation (held during Spring 2008) on the framework for the registration of health and

adult social care providers and consultation on the draft regulations. The new framework is to be introduced from 2010 and provides standards and a registration framework for the Care Quality Commission. The latter was established on 1<sup>st</sup> April 2009 and takes over from the Healthcare Commission, Commission for Social Care Inspection and the Mental Health Act Commission.

### **CLG Household Projections to 2031**

This report published on 11<sup>th</sup> March 2009 includes national and regional data.

Key points are:

- By 2031, 32 per cent of households will be headed by those aged 65 or over, up from 26 per cent in 2006.
- The number of households in England is projected to grow to 27.8 million in 2031, an increase of 6.3 million (29 per cent) over the 2006 estimate, or 252,000 households per year.
- Population growth is the main driver of household growth, accounting for nearly three-quarters of the increase in households between 2006 and 2031.
- One person households are projected to increase by 163,000 per year, equating to twothirds of the increase in households.
- By 2031, 18 per cent of the total population of England is projected to live alone, compared with 13 per cent in 2006.



# FEATURE ON THE CREDIT CRUNCH

#### **Crunch times?**

Prior to the current financial problems the older persons' housing market had seen an expansion, increasing development of extra care models, including retirement villages, assisted living, PFI and remodeling of sheltered housing amongst others. Private and public sector models were becoming more aligned around 'Quality of Life', offering older people greater choice including choice of tenure, more two bedroom accommodation, increased space standards and on site facilities and services.

Whilst the credit crunch has not stopped development, it is having an impact, specifically:

- Completions of sales of retirement housing are down in line with the general housing market. There are a number of reasons for this, including difficulties selling family houses because buyers down the chain are finding it difficult to borrow; uncertainty around falling property values and reduced interest on savings and investments resulting in reduced income
- Transferring properties for sale or shared ownership to rent, particularly in mixed tenure developments
- RSL's and private developers finding it harder to renegotiate loans and/or raise new finance

However on the positive side, construction costs are reduced; rented and to a lesser extent shared ownership for older people is more secure than mainstream housing for sale because of secure capital and revenue funding streams and there are some signs of increasing availability of sites for example where plans for private sector housing for sale have been abandoned.

It is predicted that the current problems will be felt across the older persons housing care and support market for many months to come and will test the innovation and ingenuity of RSL's and the private sector alike to continue to develop.

### RESEARCH UPDATE

# <u>Enriching people's lives – building up the</u> evidence base

People living in extra care housing have a variety of mental health needs. This research programme, recently completed a 2 year cluster randomised

controlled trial, the Enriched Opportunities Programme (EOP), led by a senior member of staff called a 'Locksmith'. Five extra care housing schemes were randomly assigned to receive the EOP Locksmith for an 18 month period. A further 5 housing schemes were randomly assigned to receive a placebo



intervention for the same time period. The programme followed the lives of the 268 most vulnerable residents living in these schemes. Early findings show that the process of implementing EOP and the impact on people's lives has been very positive and residents were:

- Half as likely to have to move out into a care home
- Spent far less time in hospital as an in-patient
- More likely to have a GP visit
- More likely to see a community physiotherapist, occupational therapist and a chiropodist
- More likely to have their mental health problems diagnosed
- Rated their Quality of Life more positively
- · Decreased symptoms of depression
- Feelings of social support and inclusion were greater

# New model for service user involvement to launch in Stoke

Stoke-on-Trent City Council is working with purchasing consortium Independent Healthcare Procurement (IHP) to launch an assessment framework which surveys how local health and social care users make choices about the services they purchase.

The proposed survey will involve 200 service users in Stoke and, if successful, the research model will be rolled out to local authorities across the UK. The results will help councils become more sensitive to the needs of users, supporting vulnerable people to exercise choice and control over the services they want. Beginning in May 2009, the proposed survey will be conducted via a series of face-to-face interviews, phone calls and e-surveys throughout Stoke-on-Trent. Focus groups will be used to gain more detailed information. Results will be published in late summer 2009.

# **Developing extra care**

### **EVOLVE:** a call for research participants

EVOLVE is a three year research project funded by the Engineering and Physical Sciences Research Council (EPSRC) and being carried out by an interdisciplinary team from The University of Sheffield and PSSRU, The University of Kent, with the aim of developing an evidence-based tool for evaluation and assessment of extra care housing design, and assessing the wellbeing of the people living and working there.

A pilot version of the EVOLVE tool is being used between now and September in a nationwide survey of 25 extra care housing schemes of all types (villages, smaller new build schemes and remodelled schemes in both the public and private sectors), alongside scheme resident interviews, in an evaluation of the building design. The research team are currently recruiting schemes to join the research, and would welcome offers of participation. The EVOLVE tool will be refined and modified in the light of the survey findings, and a final version will be produced. A web-based version of the tool will also be made freely available to Housing LIN members to download. Research participants will be invited to attend feedback days when the results will be summarised and the final version of the EVOLVE tool will be presented.
