An Election Update

Further to the recent general election, the new Ministerial team at the Department of Health is:

- Andrew Lansley Health Secretary;
- Simon Burns MP Minister of State for Health;
- Paul Burstow MP Minister of State for Care Services;
- Anne Milton MP Parliamentary Under Secretary of State for Public Health;
- Earl Howe Parliamentary Under Secretary of State for Quality.

In particular, Paul Burstow MP - Minister of State for Care Services, portfolio includes Long Term Care Reform; Adult Social Care; Carers: Personal Health Budgets; Safeguarding Vulnerable Adults; End of Life Care; Long Term Conditions, including cancer and diabetes; Dementia; Mental Health; Physical Disabilities; Autism; and Learning Disabilities.

In addition, on 20th May 2010, the main policies for the Conservative/ Liberal Democrat coalition government were published in The Coalition; Our programme for government. This includes proposals on:

- promoting shared ownership and social tenants to own/part buy

PRACTICE NEWS

Registration with Care Quality Commission

If you are a commissioner or provider of Extra Care Housing, please note that the Care Quality Commission is introducing a new system of registration for all providers of social care (and health) services under regulations set out in the health and Social Care Act 2008 (Regulated Activities) Regulations 2009 and the Care Quality Commission (Registration) Regulations 2009. The same set of standards of quality and safety will apply to all social care (and health) services including long term care in residential and nursing homes and

care in people's own homes, including extra care. Providers of social care must be registered under the new system from 1st October 2010 and can apply for registration from now until 1st August 2010.

The regulations include a definition of extra care housing:

'These services cover many different arrangements. Usually, they consist of purpose built accommodation in which varying amounts of care and support can be offered, and where some services and facilities are shared. The care the people receive is regulated by the Care Quality Commission, but the accommodation is not.'

Telling the story of Hartfields: A new retirement village for the twenty-first century

In 2008 the Joseph Rowntree Housing Trust, in partnership with Hartlepool Borough Council and other local agencies, opened the DH funded Hartfields retirement village in Hartlepool. This study tracks key decisions made and challenges faced as the scheme developed. It found that:

It is crucial to develop realistic expectations and an understanding of what these schemes can offer residents.

Locating GPs and specialist nurses in the scheme provides opportunities to promote healthy living and well-being in later life, both for residents and the wider community.

It is important for planners to understand how the local community and culture will shape the new community that evolves.




in housing from across the South East region of England.

Making HAPPI Happen



Fire safety in ECH

In addition, Faithful + Gould are in the process of researching and writing a technical brief on Fire Safety in Extra Care Housing and would like to hear from you in relation to:

- Details of non standard Extra Care Housing designs (i.e with atria, winter gardens, open plan foyer etc) and how the design team approached the Fire Engineering aspects when applying for Building Regulations approval together with any special arrangements related to smoke and fire detection and controls.
- Details of any design relaxations obtained due to the inclusion of sprinkler and misting systems in Extra Care developments.
- Examples of Fire Evacuation Strategies for Older Persons and Extra Care Housing and dialogue held with the landlord, design teams and Building Controls Officers in order to arrive at an acceptable outcome.

Commission of Enquiry into closer co-operation between Housing, Health and Adult Social Care in South Essex

A Commission of Enquiry into closer co-operation between Housing, Health & Adult Social Care is being set up to examine the role housing and housing-related services need to play to deliver personalised services alongside health and social care. The Commission's work will cover the five Councils and two PCTs in South Essex - Essex, Basildon, Rochford, Castle Point, Southend-on-Sea and Thurrock Councils, and NHS South West Essex and NHS South East Essex. It will also need to harness the investment and creativity of the third and private sectors in the delivery of these services in the sub-region.

The Commission's work is designed to start with the citizen and consider how, through a more collaborative approach between housing, health and adult social care these services can more effectively manage demand for high cost health and social care services whilst achieving a more responsive, personalised offering which supports independence and quality of life. The intention is to drive out duplication of effort, seek more cost effective solutions and reduce reliance on expensive (and often unpopular) provision such as residential care.
