POLICY AND FUNDING NEWS:

There have been a number of major policy announcements since our summer enews. In particular, around government funding commitments over the next three years and arrangements to support the development of reablement/care at home agenda.

Comprehensive Spending Review - challenge or opportunity?

On 20 October, the government set out its fiscal strategy for the next 3 years. There have been significant reductions in a number of policy and funding areas that impact on future capital and revenue investment in housing related care and support services.

Health and social care

The total health budget will increase marginally by 0.4% in real terms (above inflation) – 0.1% above inflation each year, with productivity savings of up to £20billion sought over the next 4 years through greater efficiencies. There is also a greater thrust towards closer integration of frontline services and local commissioning to achieve greater service quality. Further details of these arrangements will be set out in the forthcoming NHS Operating Framework for 2011/12 due out next month.

With regard to social care, the context is that there is a 26% reduction in revenue grants to local authorities. However, in his letter to Directors of Adult Social Care, David Behan – Director General at the DH – highlighted the challenges of the fiscal climate and that the spending review recognized the importance of social care. To this end, an additional £2billion has been allocated to aid the delivery of social care by 2014/15. This includes £1billion of NHS monies to be used by health services to support reablement services to help avoid demand on social care and a further £1billion social care revenue grant monies for local authorities, in addition to existing allocation arrangements. There will also be further announcements on other specific grants relating to Learning Disability and Health Reform Grant, Public Health grants and any further capital allocations at a later date. For those readers with an interest in Extra Care Housing funding, no specific allocation was made at this time. We will report on any developments as and when these arise.

Housing and related support

As with social care, the delivery of housing will be affected by reductions in revenue in grants to local authorities. However, specific mention is made to protecting vulnerable people, including:

- Disabled Facilities Grants to rise in line with inflation
- Over £6.5billion Supporting People budget (as part of new formula grant arrangements), and
- £400million homelessness grant
- £100million New Homes Bonus (to stimulate housing/economic growth)

In addition, the government has set a target of 150,000 new affordable homes over the Spending Review period while at the same time reducing the Homes and Communities Agency capital programme to £4.5billion. At the same time, £2billion has been set aside for landlords to complete their Decent Homes and future disabled housing adaptations. There is also mention of the reform of Housing Revenue Accounts and setting new Affordable Tenancy with flexible tenure arrangements and intermediate rent levels. More details to follow.

Further to the Chancellor of the Exchequer's June statement, another key strand of the CSR was set aside for Welfare Reform. This includes:

- increasing the age threshold for the shared room rate from 25-35 years of age instead of a rate for a full flat, and
- removing the mobility component of Disabled Living Allowance for those people living in residential care.

Speaking at the National Childrens and Adult Services conference last week, Andrew Lansley, Secretary of State for Health, spelt out how £800m of the additonal monies set aside for social care in the CSR for 2011/12 will be spent. This includes £150m for reablement services for people leaving hospital, backed by new rules that will make hosptal trusts responsible for patients for 30 days after their discharge. The latter builds on an earlier announcement of £70m (outlined in the next item). Further details to appear in our next edition of this enews.

£70m for reablement services

The Secretary of State for Health, Andrew Lansley, has announced a £70m cash boost to enable the NHS to support people back into their homes after a spell in hospital. The package will help to settle people back into their homes, possibly through fitting adaptations to their home environment so they can get around better or providing daily visits and support. The extra funding will be allocated to Primary Care Trusts to be spent this financial year across the health and social care system. Prominent Bodies to be abolished or reformed

The Cabinet Office have announced the reform of a number of prominent Quangos and the abolishment of several that have a direct engagement with the regulation, advice and inspection of housing and local government. Those to be abolished include the Audit Commission, the Tenant Services Authority, Rent Assessment Panel, and National Housing and Planning Advice Unit. Those to be reformed include the Independent Housing Ombudsman and the Homes and Communities Agency. Full story at:

- Ensuring that the work they do is planned and informed by the views of people with dementia and their carers
- Being an ambassador for the National Dementia Declaration and securing commitment from partners for the second phase of the Declaration

- Reporting publicly on their progress against the plan they have set out to support delivery of the National Dementia Declaration
- Working in partnership with other organisations to share knowledge about best practice in dementia
- Improving understanding about dementia

EVOLVE – The Evaluating Older people's Housing toolkit

This comprehensive toolkit by the University of Sheffield, with PSSRU, University of Kent and supported by the Housing LIN should be used to assess how well a building contributes to both physical support of older people and their personal well-being. It consists of a set of detailed checklists ordered in the sequence of the rooms or spaces encountered in a walk through a building.

Assisted living services in 2030

A recent study commissioned by Ofcom examines the long-term requirements of key sectors for communication services in the United Kingdom and considered: how assisted living services (ALSs) might help older people and disabled people to live more independently over the next 20 years; the technology driving development of ALSs; and barriers to 'digital inclusion'.

Kent Telehealth Pilot Study

In 2004, Kent County Council with their primary care trusts initiated a ground breaking telehealth pilot programme involving 250 patients. The pilot programme initially set out to establish whether outcomes from US studies could be replicated in the UK. This included supporting user



independence, alleviating carer burden, assessing impact on hospital admissions, length of stay, GP contact and nursing visits. Three long term conditions were included in the home monitoring study - Chronic Obstructive Pulmonary Disease (COPD), Coronary Heart Disease (CHD) and Type 2 Diabetes.

In a major recent report, the study concluded that:

- Telehealth brought peace of mind and improved quality of life for patients and carers
- Telehealth supported independence, empowerment and self-management of conditions
- Patients and carers embraced the technology and valued it
- People who used telehealth had fewer hospital admissions, shorter lengths of stay, reduced GP contacts and in some cases fewer nursing visits
- Clinicians had regular and reliable patient information and could take appropriate early action to prevent admissions and exacerbations
- Telehealth promoted better medicine management
- Financial savings were possible through reduced unplanned admissions, A&E visits and clinician home visits

A rough extrapolation of savings (with some caveats) across Kent indicates that the annual cost savings for 2006-7 could be £7.56m (Confidence level of 0.05, range of £4.18m-£10.942m).

Kent is part of the Whole System Demonstrator Programme, the World's largest controlled trial of telecare and telehealth, which will report in Spring 2011.
